60 FOR 60

Purchased 29 units since January 2018 towards our goal to acquire and renovate 60 homes in 60 months

2019 Impact

- 15 residential properties purchased
- 11 units renovated
- 13 new tenants
- 7 homes purchased with residents who were able to stay in their home
- 2 families connected with LINKS Community and Family Services
- 3 new full-time housing staff, including 2 Housing Coordinators and 1 Housing Assistant
- 200+ volunteers from Grace Church, Connect Church, Wadsworth Chapel, and the United Way Day of Action which included Sikich LLP, FedEx, Akron Children's Hospital, and the GPD Group


COMMUNITY TOOL LIBRARY AND HOME MAINTENANCE CLASSES

- Held 16 Home Maintenance Classes
- 72 Home Maintenance Class participants
- 12 volunteer instructors for Home Maintenance Classes
- 30+ hours of Home Maintenance Class instruction time
- Built-out Community Tool Library at 816 E. Market Street with the help of 8 Summa Health Systems volunteers and 1 Akron Public Library volunteer

LAWN CARE

Mowed city lots to promote neighborhood beautification, invest in our place, create jobs, and partner with the Urban League for job training

- A partnership with the City of Akron allowed us to hire 2 seasonal employees who attended a workforce series at the Akron Urban League and received an OSHA 10-hour Safety Certification
- Subcontracted 38 North Hill lots to Shanti Farms





AKRON FOOD WORKS

Opened Akron's first large-scale shared-use kitchen and incubator

- Renovated a 2,100 square foot space into a commercially licensed kitchen including dry, cooler and freezer storage
- Hired 1 full-time Kitchen Manager to help entrepreneurs navigate starting their small food businesses
- 11 active Kitchen Users
- 9 female-owned businesses
- 6 minority-owned businesses
- 140+ food-based entrepreneurs on mailing list
- Held 1- 8 hour Hudson Kitchen Food Business Bootcamp with 15 participants
- Passed its final SCPH & ODA inspections at the top of December

2020 Goals

- 40-60 kitchen users
- 4+ Hudson Food Business Bootcamps with 60+ participants
- Food Shark Tank in partnership with ACME Stores the Summer of 2020

COMPASS

- 28,024 transactions in 2019. The Middlebury neighborhood has a destination for people throughout Greater Akron to find amazing coffee and community
- Hosted community events that support Compass as a destination for Middlebury residents and Greater Akron. Events included Open Mic Nights, Latitude Poetry Night, ASIA, Inc. "Hapi Fresh" Farmers Market, Middlebury Mixer, and a wide variety of private events
- Consistent Conference Room Reservations from a variety of public and private groups including B2B Edge Chapter of BNI, Reverse Women Network, Coleman Professional Services, and Toastmasters

MIDDLEBURY GREAT STREETS DISTRICT COMMERCIAL DEVELOPMENT

 Repaired awnings and store front windows, updated roof, and completed interior renovations at 913 E. Market Street

 Developed feasibility study and drawings for the adaptive re-use of 816 East Market Street, Akron's original production facility for Ford Model-T cars. Stay tuned for renderings that will show what the repurposed building will look like!

WORKFORCE DEVELOPMENT

- Held 1 Career Open House in partnership with Summa Health Systems and ConxusNEO.
- 4 individuals hired at Summa Health Systems from event.

AKRON HOPE

- 160+ students tutored at Mason CLC and Helen Arnold CLC
- 1,900+ hours invested into students through In-Classroom Tutoring
- Mason CLC 4th Grade test scores rose 9% and IEP students' scores rose 60% compared to previous years with no other intervention
- Helen Arnold 3rd Graders scored 3 points higher than the district average on the Ohio State Test and had the highest test scores in the school. 99% of 3rd graders at Helen Arnold CLC have advanced to 4th grade since 2017
- 14 Family Engagement Events held at Mason CLC and Helen Arnold CLC
- 600+ gifts provided to students and teachers at Mason CLC and Helen Arnold CLC during annual holiday gift giving
- 650+ volunteers

647 E. MARKET STREET

Increased our ability to be a "well" for the community- a common gathering place in the Middlebury neighborhood

- 124+ special usage events hosted by The Well CDC, tenants, local nonprofits and businesses, creating a destination in Middlebury
- Notable users included the Knight Foundation, Akron Community Foundation, ArtsNOW, ASIA Inc. University of Akron EXL-Center, Torchbearers and Equitas Health
- 100% occupancy of 6,100 sq ft of leasable space for 8 of 12 mos. These rental spaces help support budding non-profits by offering administrative space for a nominal fee
- Tenants include Citizens Akron Church, ASIA Inc., H2O Church, Healing Hearts, The Business Doctor, and Fair Shake Environmental Legal Services

MB NEIGHBORHOOD PLAN

- Officially completed in March 2019
- This plan created strategic recommendations for the Middlebury community to collectively move forward and included a project timeline

COMMUNITY GARDEN AND HOOP HOUSE

• 10 Middlebury residents and stakeholders grew fresh, local produce




 The Well CDC participated in the inaugural Middlebury Cultural Festival led by LINKS Community and Family Services and other neighborhood partners




